Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Town of Costessey, or in the case of still-born children, where the parent (or one of them) are such inhabitants or electors.

All non-residents will be charged at <u>triple</u> the fees quoted above, <u>EXCEPT</u> where the deceased person was a resident of Costessey for 20 years or more and has moved from the Town within the last 5 years to recognized sheltered accommodation or residential care <u>OR</u> if the interment is into a previously purchased plot, when the Costessey rate applies.
